### Select Committee to Investigate the January 6th Attack on the United States Capitol

November 8, 2021

Dear Mr. Stepien:

Pursuant to the authorities set forth in House Resolution 503 and the rules of the House of Representatives, the Select Committee to Investigate the January 6th Attack on the United States Capitol (“Select Committee”) hereby transmits a subpoena that compels you to produce the documents set forth in the accompanying schedule by November 23, 2021, and to appear for a deposition on December 13, 2021.

The Select Committee is investigating the facts, circumstances, and causes of the January 6th attack and issues relating to the peaceful transfer of power, in order to identify and evaluate lessons learned and to recommend to the House and its relevant committees corrective laws, policies, procedures, rules, or regulations.

As manager of the Trump 2020 re-election campaign, you oversaw all aspects of the campaign. You then supervised the conversion of the Trump presidential campaign to an effort focused on “Stop the Steal” messaging and related fundraising.<sup>1</sup> That messaging included the promotion of certain false claims related to voting machines despite an internal campaign memo in which campaign staff determined that such claims were false.<sup>2</sup> The “Stop the Steal” messaging was echoed by individuals who attacked the U.S. Capitol on January 6 in an attempt to interfere with the peaceful and orderly transfer of power. Additionally, the campaign reportedly urged state and party officials to affect the outcome of the November 2020 election by, among other things, asking states to delay or deny certification of electoral votes and by sending multiple slates of electoral votes to the United States Congress.<sup>3</sup>
