### Select Committee to Investigate the January 6th Attack on the United States Capitol

November 9, 2021

Dear Ms. Hutchinson:

Pursuant to the authorities set forth in House Resolution 503 and the rules of the House of Representatives, the Select Committee to Investigate the January 6th Attack on the United States Capitol (“Select Committee”) hereby transmits a subpoena that compels you to produce the documents set forth in the accompanying schedule by November 23, 2021, and to appear for a deposition on December 1, 2021.

The Select Committee is investigating the facts, circumstances, and causes of the January 6th attack and issues relating to the peaceful transfer of power, in order to identify and evaluate lessons learned and to recommend to the House and its relevant committees corrective laws, policies, procedures, rules, or regulations.

The Select Committee’s investigation has revealed credible evidence of your involvement in the events within the scope of the Select Committee’s inquiry. In the months leading up to and including January 6, 2021, you served as special assistant to the President for legislative affairs.<sup>1</sup> You were in the White House on January 6 and were with former President Trump when he traveled to the Ellipse and spoke at the “Stop the Steal” rally.<sup>2</sup> In addition, on December 30, 2020, following Chief of Staff Mark Meadows’s trip to Georgia to attend the election audit, you reportedly reached out directly via email and phone to Georgia Deputy Secretary of State Jordan Fuchs.<sup>3</sup> In your email, you said, “I just spoke to Chief Meadows regarding his visit with you in Cobb County last week. When you have a moment, could you please give me a call.”<sup>4</sup> And, due to your role working with Mr. Meadows, you are potentially in a position to inform the Select Committee’s examination of Mr. Meadows’ efforts to communicate with others, including state officials in Georgia, about allegations of fraud that had already been dismissed by state and

federal courts,<sup>5</sup> organizers of the January 6 events including Amy Kremer,<sup>6</sup> high-level officials at the Department of Justice about federal investigations into purported voter fraud,<sup>7</sup> and U.S. Government officials during attack of the U.S. Capitol.<sup>8</sup>

Accordingly, the Select Committee seeks documents and a deposition regarding these and other matters that are within the scope of the Select Committee's inquiry. A copy of the rules governing Select Committee depositions, and document production definitions and instructions are attached.
